- SUSF reserves the right to amend these Terms & Conditions from time to time.
- SUSF reserves the absolute discretion to terminate participation in the SUSF swim school at any time for any reason.

- If you require information regarding your child's progress please contact the Swim School Manager or Coordinators in person or by email.
- Due to time constraints and in the interest of all swimmers, if you would like to speak to an instructor or coach please email swim school and the information will be passed to them.

APPLICATIONS

- Application forms must be completed and signed by a responsible person or parent over the age of 18 years.
- All swim school participants, except preschool participants, must be assessed before joining any swim school program. For a free assessment please contact swimschool@sport.usyd.edu.au
- Places are subject to availability and at the discretion of SUSF.
- All relevant medical information must be declared at the time of application.

PHOTOGRAPHY AND VIDEO RECORDING

- No photography or video recording is permitted in the Sydney Uni Sports and Fitness Centre or Aquatic Centre.

PAYMENTS

- The Swim School programs operate in accordance with the NSW Public School Terms calendar.
- Term payments must be made in full before the start of the first lesson. If payment has not been made admission to the lesson will not be permitted.
- All Squad fees are due on or by the 1st of each month to secure placement.
- All participants will receive a Swim School card to be presented at each visit to the Sports & Aquatic Centre reception prior to each lesson to record attendance.
- Fees payable are subject to change at anytime.

DISCOUNTS

- SUSF offer 10% discount for Learn to Swim participants who book 2 or more lessons per week.
- SUSF offer 10% discount for Learn to Swim participants for 2nd or more children.
- Discounts cannot be combined.
- There are no other discounts available for any other programs offered by SUSF.
- The discounts offered are subject to change without notice.

CREDITS

- Requests for credits must be made by email to swimschool@sport.usyd.edu.au and will be at the discretion of the Swim School & Programs Manager.
- SUSF offer, as a courtesy, 2 make-up lessons per term when 72 hours notice by email is given or on receipt of a medical certificate.
- Requests for make-up lessons that do not meet the required 72 hours notice will incur a \$5 charge per lesson.
- Requests for any additional make-up lessons will incur a \$5 charge per lesson
- Refunds will not be given for partial attendance of any lesson, nor will make-up lessons be provided.
- All make-up lessons are subject to availability and are at the discretion of the Swim School & Programs Manager. In particular, SUSF cannot guarantee the provision of make-up classes for one-on-one lessons.
- Make up lessons must be completed in the term the classes were missed. No make up lesson will be carried forward to the next term or holiday program. No make up lesson can be booked more than seven days in advance.

SPECIAL NEEDS PROGRAM

- SUSF offers a Special Needs swim program for children who are assessed by SUSF as being unable to join a group lesson due to a disability.
- Special Needs classes are conducted on a one-on-one basis, and participants are offered a significant discount as compared to the usual rate for one-on-one classes.



- Given the discounted arrangement that applies to Special Needs classes:
 - The volume discounts set out above do not apply to Special Needs classes; and
 - SUSF cannot guarantee the provision of one-on-one make-up classes

REFUNDS

All requests for refunds must be made by email to swimschool@sport.usyd.edu.au and will be at the discretion of the Swim School & Programs Manager.

- Refunds will only be given if lessons cannot be attended for medical reasons which must be supported by a medical certificate or moving over 10km out of the area.
- An administration fee of \$25 will be incurred on all refunds.

CONDITIONS OF POOL USAGE

- The health, safety and well-being of all participants and staff are paramount; all participants and parents must follow safety guidelines and instructions given by any member of SUSF staff. This may include reinforcing clear guidelines.
- All participants must adhere to the SUSF Facility Code of Conduct. Breach of this Code may lead to termination of participation in the SUSF Swim Program. By completing and signing this application form you have read and understood the terms and conditions and the SUSF Facility Code of Conduct which is available on SUSF website www.susf.com.au
- Parents with children under 10 years of age must escort their children into the facility and remain with their child in view while the child is participating in lessons.
- Parents and guardians are expected to take full responsibility for their children upon entry to SUSF. SUSF does not take any responsibility for the supervision of children outside of their allocated swimming lesson. Swim School families are required to maintain appropriate behaviour whilst within SUSF. All children must be supervised at all times outside swim lessons.
- SUSF reserves the right to refuse to allow participation of anyone suffering from or displaying symptoms of any illness including but not limited to contagious diseases. If your child is suffering from a contagious disease or infection please do not bring them to the facility. SUSF reserves the right to refuse entry to any child or adult.
- Swimming caps must be worn by ALL participants at all times during lessons and at all other times.
- To swim before or after any swim school program all supervising responsible persons, parents, caregivers and participants must be a SUSF member.
- Any person not enrolled in the swim school must pay the required additional fee to use the pool.
- No running around the pool area.
- No food and or glass bottles are permitted in the pool area.
- Appropriate swimming attire is required at all times.

RELEASE

I am aware that recreational, fitness and sporting activities carried out by Sydney Uni Sport & Fitness (SUSF) including but not limited to the SUSF Swim School Program, are dangerous undertakings and in undertaking such activities do so at my minor child/ward's or own risk. I recognize that such activities require physical exertion which may be strenuous and may cause physical injury and I am fully aware of the risks and hazards involved.

I am also aware that SUSF, its directors, instructors, members, servants or agents are absolved from all liability howsoever arising from injury (whether fatal or otherwise) or damage (including to property), howsoever caused arising out of involvement with SUSF or from participating in any of the sporting, fitness and recreational activities offered by SUSF, or in any way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of SUSF, its directors, instructors, members, servants or agents.

I voluntarily agree to assume the risk of any injuries, damages or loss, regardless of severity that my minor child/ward or I may sustain as a result of being a participant in the activities connected with or associated with my minor child/ward's or own involvement with the SUSF Swim School Program.
